

Section 3.02 Ordinance Violation Penalties

3.02(A) Title/Purpose

The title of this Section is Ordinance Violation Penalties. The purpose of this Section is to set forth the appropriate penalty for violation of the Town's Code of Ordinances .

3.02(B) Penalties for Ordinance Violations

Pursuant to Wis. Stat. § 66.0113, the Town of Leeds is authorized to issue citations for violations of ordinances, including ordinances for which a statutory counterpart exists.

3.02(C) Penalty Range

Any person who shall violate any of the provisions of this Code shall upon conviction of such violation, be subject to a penalty, which shall be determined according to the following schedule:

3.02(D) Additional Fees

In addition to the appropriate cash deposit amount as established above, all citations issued under this Section shall further specify the corresponding penalty assessments, court costs, court automation fee, and jail assessment.

3.02(E) Payment

Deposits shall be paid in cash, money order or cashier's check to the Columbia County Clerk of Circuit Court who shall provide a receipt therefor.
