

**Section 3.03 Schedule of Deposits**

**3.03(A) Title/Purpose**

The title of this Section is Schedule of Deposits. The purpose of this Section is to set forth the appropriate deposit for violation of the Town’s Code of Ordinances.

**3.03(B) Authority**

Pursuant to Wis. Stat. § 66.0113, the Town of Leeds is authorized to issue citations for violations of ordinances, including ordinances for which a statutory counterpart exists.

**3.03(C) Schedule of Deposits**

Any person who shall violate any of the provisions of this Code shall, pursuant to options set forth in Wis. Stats. 66.1113(3) and set forth in the citation, make a cash deposit determined according to the following schedule:

**3.03(D) Additional Fees**

In addition to the appropriate cash deposit amount as established above, all citations issued under this Section shall further specify the corresponding penalty assessments, court costs, court automation fee, and jail assessment.

**3.03(E) Payment**

Deposits shall be paid in cash, money order or cashier's check to the Columbia County Clerk of Circuit Court who shall provide a receipt therefor.

**3.03(F) Unspecified Deposits**

The deposit for any other Section of this Code not otherwise addressed or specified herein shall be \$50.00 for the first offense. The forfeiture amount shall double for the second offense if such subsequent offense occurs within two (2) years of the prior offense for which a conviction has been obtained.
